### SECTION 2 — HAZARDS IDENTIFICATION

Flinn Suggested Chemical Storage Pattern: Organic #2. Store with alcohols, glycols, sugars, amines, amides, imines and imides. Hygroscopic. Store in a cool, dry place within a Flinn Chem-Saf™ bag and then inside a Flinn Saf-Stor™ can. Keep cool (P235). Keep container tightly closed (P233). Use only in a hood or well-ventilated area (P271). Ground or bond container and receiving equipment (P240). Use explosion-proof electrical and ventilating equipment (P241).
