

Potential Health Effects

Irritation is due to the hygroscopic nature of ammonium iodide.

Inhalation:

May cause irritation to the respiratory tract.

Ingestion:

May cause temporary enlargement of salivary glands or lymph glands. No fatalities have been reported from iodide poisoning.

Skin Contact:

May cause irritation.

Eye Contact:

May cause irritation.

Chronic Exposure:

Prolonged or repeated exposure through ingestion may cause iodism. Symptoms include salivation, sneezing, conjunctivitis, headache, fever, bronchitis, stomatitis, and skin rashes. Prolonged or repeated skin contact may cause dermatitis.

4. First Aid Measures

Inhalation:

Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Call a physician.

Ingestion:

6. Accidental Release Measures

7. Handling and Storage

A full-face piece particulate respirator (NIOSH type N100 filters) may be worn up to 50 times the exposure limit, or the maximum use concentration specified by the appropriate regulatory agency, or respirator supplier, whichever is lowest. If oil particles (e.g. lubricants, cutting fluids, glycerine, etc.) are present, use a NIOSH type R or P filter. For emergencies or instances where the exposure levels are not known, use a full-facepiece positive-pressure, air-supplied respirator. WARNING: Air-purifying respirators do not protect workers in oxygen-deficient atmospheres.
